#### **SUMMARY OF FINDINGS:**

The research objective for this session has been partially met. The Roman Catholic Parish of Rathcormack (sometimes abbreviated as RC) comprises of both Rathcormack and Gortroe areas. The church records are located in the Diocese of Cloyne, and the Parish of Rathcormack and Gortroe, in County Cork. For Catholic Parish records, Gortroe has been amalgamated into Rathcormack. I've expanded on this further in my research. Additional children's baptismal information, including a first born son named David Mara was found at the Church of Rathcormack in 1808, and another daughter named Ellen was born in 1811. A second Ellen was baptized in 1821, implying the first one likely passed away before then. The parish records are very faded in places, but I could not find a record for either John Jr. or Thomas between 1805-1821, at Rathcormack or other nearby parishes.

Presuming David was the first born in 1808, this implies a marriage for John and Johanna likely took place before 1807. I could find no visible records for them in the Rathcormack parish records. I did find the location of residence for the family for several of their children born during 1814-1821. The family lived in Ballyogaha, Gortroe, Cork, Ireland

John Mara's death and burial have not been located. At the Archives, we researched all Lanark cemeteries and newspapers and could not find any reference to a death for John Mara/O'Mara/Meara... in Lanark County from 1841-1852. I suspect the family moved south together after the land at Lot 9, Con 9 was sold in 1849. I was told by the Lanark Archives Archivist: had John been deceased in 1849 it would have read "the Estate of..." but it clearly shows "John O'Meara and wife" on the land records for 1849, implying he was alive then. I'm unsure if he widowed her or if his wife died first in 1852. It is probable he is buried in Huron-Perth or Middlesex Counties, in southern Ontario. I can find no burial records for him under any spelling or even a misspelled name.

Many family trees on *Ancestry* have a false death date of abt 1845. I can find no reference to this source and have presumed it is an estimated death.

Additionally, the death date shown as 23 Jul 1857 Ottawa on some Ancestry trees belong to a 5-year-old child, not John Mara. There is another burial record for a William Omeara (which has been mistakenly interpreted as the first name of John) for Jul 1847 Ottawa. This is also not the correct record for John Mara. I have included this in my notes for John Mara's death in the GEDCOM file.

To mention, on the "[PRIVATE]" Ancestry tree, John Mara's father is presumed to be Patrick Mara (1743-1768). His death date is before John is born, so this could be a relation, but more a grandfather to John. I am not certain yet as we would need to prove John's own parentage first. I have not found John Mara's birth/baptismal record, as the records for the Rathcormack church do not begin until 1792.

#### A DETAILED LOOK:

#### JOHN MARA AND JOHANNA FOLEY

I present a look into John Mara's life through a journey of discovery of documents and images. Beginning with his birth in Ireland through his journey to Canada. The following Irish baptismal records are written in Latin. Names such as John were spelled as Joannis, and James was Jacobi, Brigidam for Bridgid, Mariam for Mary, Davide for David, etc.<sup>2</sup>

**John MARA (O'MEARA)** was born in 1781 at \*probable\* Garryantaggart, Co. Cork and died after 1849 in southern Ontario (then known as Upper Canada until Confederation in 1867), Canada.

John MARA (O'MEARA) and Johanna FOLEY were married before 1807 at \*probable\* County Cork in Ireland and had the following children:

i. **David MARA** appears to be the first born son of John and Johanna, as there are no Mara records prior at Rathcormack. He was born on 27 Jan 1808 in Rathcormack and Gortroe Parish, County Cork, Ireland.<sup>3</sup> He was baptized on 27 Jan 1808 in Rathcormack and Gortroe Parish, County Cork, Ireland; Witnesses were John Dinan (Dineen is a variant in the area) and Johanna Keily.

In 1823, she emigrated with her family abourd the HS Stakesby from Ireland to Canada. She married Mr. UNK, bef 1861; died 4 Dec 1882, Usborne, Huron-Perth, Ontario, Canada. She is buried at Saint Patrick's RC Church Cemetery in Lucan Biddulph, Middlesex, Ontario, Canada.

iii. **Ellen MARA** was born on 10 Mar 1811 in Rathcormack and Gortroe Parish, County Cork, Ireland.<sup>5</sup> She was baptized on 10 Mar 1811 in Rathcormack and Gortroe Parish, County Cork, Ireland; Witnesses were Thomas Shea and Abigail Donovan.





He is buried at Saint Patrick's RC Church Cemetery in Lucan Biddulph, Middlesex, Ontario, Canada. He was a Farmer.
- v. **Johanna MARA**, born on 27 Sep 1814, Ballyogaha, Gortroe, County Cork, Ireland; She was baptized 27 Sep 1814 at Rathcormack and Gortroe Parish, Cork, Ireland; Witnesses were Jacob Foley and Maria Cotter. Address is shown as "B. Gaha" which was shorthand for Ballyogaha.



She married Denis FINN, 6 Nov 1848, at St. Philip's Nepean RC Church, Richmond Village, Ottawa, Carleton, Ontario, Canada; died 19 May 1890, Cleveland, Le Sueur, Minnesota, United States. She is buried in Calvary Cemetery, Cleveland, Le Sueur, Minnesota, United States.

vi. **Bridget MARA**, born 6 Feb 1817, Ballyogaha, Rathcormack and Gortroe Parish, County Cork, Ireland; She was baptized 6 Feb 1817 at Rathcormack and Gortroe Parish, Cork, Ireland; Witnesses were Mauritii Mulcahy and Bridget Mulcahy. Address is shown as "Balogaha" which was Ballyogaha.



In 1823, she emigrated with her family abourd the HS Stakesby from Ireland to Canada. She married Michael DWYER, 5 Oct 1841, at St. John the Baptist RC Church, Perth, Drummond Township, Lanark, Ontario, Canada; died 1891, Le Sueur County, Minnesota, United States. She was buried at Saint Henry Catholic Church Cemetery in Saint Henry, Le Sueur, Minnesota, United States.

vii. **Thomas MARA**, born abt. 1819, Rathcormack and Gortroe Parish, County Cork, Ireland. In 1823, he emigrated with his family abourd the HS Stakesby from Ireland to Canada. He married Margaret FOLEY, 3 Jun 1846, at St. Philip's Nepean RC Church, Richmond Village, Ottawa, Carleton, Ontario, Canada; died 2 Jul 1894, Kilkenny, Le Sueur, Minnesota, United States. He was buried at Calvary Cemetery, Kilkenny, Le Sueur, Minnesota, United States. His will is dated 2 Jul 1894 and probate 11 Sep 1905, Cordova, Le Sueur, Minnesota, United States.

viii. **Ellen MARA**, born 13 Aug 1821, Ballyogaha, Gortroe, County Cork, Ireland; She was baptized on 13 Aug 1821, Rathcormack and Gortroe Parish, Cork, Ireland; Witnesses Bartholomew Coleman and Maria Ryan. Address is shown as "B. Gaha" which was shorthand for Ballyogaha.



## THE MARA FAMILY IN CORK, IRELAND

Before John Mara, wife Johanna Foley, and his family were known in Canada and Minnesota, they lived in County Cork, Ireland. The following pages show a closer view of the exact townships where the family lived and their children were born. Using the following maps from as early as 1777 to 1838, I'll focus on Rathcormack, Cork, Ireland as a focal point. The Mara family would have likely traveled along this route to get to Rathcormack (shown as Rathcormuck).




Figure 3: Map Key for Taylor and Skinner Road Maps 1777

Figure 5: Map of County Cork, Ireland:





Figure 6: Historic Map of County Cork, Ireland dated 1837 by Samuel Lewis (Close-up):13,14



# ABOUT GORTROE CIVIL PARISH, CORK

The main places which have been mentioned for the Mara family in Ireland were located within Gortroe civil parish in barony of Barrymore, County Cork, Province of Munster, Ireland. The family lived in Ballyogaha during 1814-1821, based on confirmed source records from the children's baptisms at the Catholic church in the Parish of Rathcormack and Gortroe, Diocese of Cloyne. Ballyogaha is located in Gortroe Parish.

"GORTROE, a parish, in the barony of BARRYMORE, county of CORK, and province of MUNSTER, 2-miles (S. by E.) from Rathcormac, on the road to Middleton; containing, with the parish of Desert, 2856 inhabitants; and comprising 8885 statute acres, as applotted under the tithe act, and valued at £6046 per annum: about 1500 acres are bog and mountain waste, the remainder arable and pasture; the soil is in general poor. The principal seats are Ballinterry, the residence of the Rev. Archdeacon Ryder; and Holly Hill, of S. Croker, Esq. It is a rectory and vicarage, in the diocese of Cloyne, united from an early period to the rectory and vicarage of Desert, forming the corps of the archdeaconry of Cloyne, in the gift of the bishop: the tithes of the united parishes amount to £415. 7. 8. There is neither glebe-house nor glebe. The church was built in 1826. In the R. C. divisions, it is part of the union or district of Rathcormac, and contains a chapel.

There is a parochial school of about 20 children, to which the rector contributes £5 annually, and a private school of about 60 children." – Excerpt from Wikipedia entry 16

#### THE PENAL ERA IN CLOYNE

It is well documented the Mara's were a Catholic family. "In 1652 Cromwell's conquest of Ireland was complete. Persecution Catholics followed. In 1698 Catholic Bishops, V.G.s, Deans, Jesuits, and monks were ordered to leave the country and many Penal Laws were enacted. The practice of religious devotion at holy wells, for the most part, was widespread. Unregistered priests celebrated Mass on mass-rocks in the open or well concealed spots while scouts watched. Clerical students went secretly to the Irish Colleges on the continent and newly ordained priests were obliged to enter secretly on their return to Ireland. The Irish College at Toulouse was virtually a seminary for the Diocese of Cork, Cloyne and Ross. It was suppressed in 1789. This was the age of Mass-rocks and miserable open-ended Mass-houses. The majority of the priests were "on the run."" – Excerpt from Diocese of Cloyne History<sup>19</sup>

#### 19TH – 20TH CENTURY:

"The 19th and 20th centuries witnessed great progress, with convents, monasteries and schools being founded in many parishes. Numerous priests, religious men and women went to work in all five continents. The great age of Church building dawned shortly before 1800 A.D. St. Mary's Church, Youghal was built in 1796, and gradually new parish churches were built in every parish in the Diocese." – Excerpt from "Diocese of Cloyne A.D. 2002 – A glimpse of our Christian Heritage."

The Church of the Immaculate Conception, Main Street, RATHCORMACK, Rathcormack, Cork was built about 1818.<sup>20</sup>

Saint Bartholomew's Church, GARRYANTAGGART, Bartlemy, Cork was built about 1820.<sup>21</sup> This church is adjacent to <u>Gortroe Cemetery</u>. It is close to Ballyogaha.

Saint Catherine's Catholic Church, BALLYNOE, Ballynoe, Cork was built circa 1815-1820.<sup>22</sup>

St. Nicholas Church, CASTLELYONS was built in 1845 by Fr. Patrick Duggan, replacing an older thatched penal church.<sup>23</sup> Uncertain of the date the thatched penal church was built. It is close to Ballyogaha.

Saint Patrick's Church, Chapel Square, FERMOY, Fermoy, Cork was built around 1810/11.<sup>24</sup> It is near the townland of Rathcormack.

#### HOLY WELLS OF COUNTY CORK

Many churches were built after John was born. Knowing many priests practiced outside of churches due to prosecution, there could be a possibility he was baptised in a penal church or a holy well. Holy Wells were long ago created by Pagans and later on, were adopted by Christians alike for special circumstances and prayer. County Cork has the highest density of holy wells in the country.<sup>25</sup> There is a well known one called St. Bartholomew's Well, in Garryantaggart, Cork. "According to Power writing in 1923 the townland name Garrynataggart or Garraidh an tSagairt in Irish means 'the priest's garden'. The well is dedicated to St. Bartholomew who was one of the twelve apostles."




Figure 9: St. Bartholomew's Holy Well, Garryantaggart - shown surrounded with a modern enclosing wall

# JOHN MARA'S BIRTHPLACE:

#### **GARRYANTAGGART**

A few Ancestry trees suggest "Garryantsagart" as his birthplace.<sup>27</sup> This is a spelling error, but likely was copied from a document of reference – therefore I'm treating it as a valid possibility. The Township of <u>Garryantaggart</u> (how it is spelled correctly) falls midpoint between Townships of <u>Rathcormack</u> and <u>Ballyogaha</u>. Garryantaggart is also in the same Parish of Gortroe as Ballyogaha, a known place his children were born. The probability of this is good as a birthplace for John O'Mara/Mara. I have contacted several Ancestry members who show this information in hopes of a response and clarification of source for his birthplace, but it can be "penciled" in for now.





Figure 12: Continuing to zoom out - Garryantaggart is in the center of this map:

#### **BALLYOGAHA**

Ballyogaha is just above the word "Caherduggan" -must zoom into the map to see it appear... This is where the family lived (confirmed) from 1814-1821. It is possible they were here longer or before that year, but several baptismal records do not indicate town of residence. The family lived in proximity to the Catholic church in the Parish of Rathcormack from about 1808 onward. Ballyogaha is divided into three sections: East, North, and West – with West being the largest section. It might be possible to find an exact location for their homestead with further documentation discoveries in Ireland. Finding it on a map, shows it is just above Caherduggan and was in close view of the old relic Rathcobane Castle.




Figure 16: Ballyogaha:




Figure 18: Ballyogaha North, County Cork:




Figure 19: Ballyogaha West (the largest), County Cork:





Figure 21: Contemporary Google Map of Ballyogaha (in blue):




Figure 24: Zoomed out of map, showing Rathcormack Parish:




Figure 25: Zoomed out fully shows Rathcormack near the upper left:

Peter Robinson Settlers - Stakesby passengers July 1823

#### ABOUT PETER ROBINSON, 1785-1838

"Peter Robinson, the eldest son of Christopher Robinson, an officer in the Queen's Rangers, was born in New Brunswick in 1785. His family moved to Upper Canada in 1792, settling first at Kingston, and then at York in 1798. In 1812 Robinson commanded a rifle company at the capture of Detroit and in 1813 distinguished himself at the defence of Michilimackinac. In 1817 he was elected to the Legislative Assembly of Upper Canada for the east riding of York. In 1823 and 1825 Robinson promoted emigration schemes which successfully settled large numbers of Irishmen in the Bathurst and Newcastle districts in the neighbourhood of Peterborough, which was named after him. In 1827 Robinson was appointed.

Commissioner of Crown Lands, with a seat in the Executive and Legislative Councils. He continued in that office until 1836, when the entire Executive Council resigned in a disagreement with Sir Francis Bond Head. Robinson died, unmarried, in Toronto, 8 July 1838.

"In 1955 the Ontario Department of Public Records and Archives microfilmed the Robinson Papers in the possession of the Peterborough Public Library. These manuscripts, some 1500 pages, relate primarily to the emigration schemes of 1823 and 1825, and a description of the items filmed is here appended. Finding aid no. 134 lists the contents of reels M-140 and M-141 and is available at the beginning of both reels.""31 — Excerpt from Finding Aid 134, Ottawa Archives

# SHIP H S STAKESBY, 8 JUL 1823 OUT OF THE COVE OF CORK, IRELAND TO CANADA:

Mara family left with nearly 200 Irish families out of the Cove of Cobh in County Cork, Ireland on the HS Stakesby July 8, 1823. After a passage of 8 weeks, they arrived at the edge of Quebec on September 2<sup>nd</sup>. They sailed on to Montreal (Quebec) and reached it on September 6<sup>th</sup> and then they set out to boats to Prescott, another 320 miles and didn't arrive until September 22<sup>nd</sup>. The Mara's ended up in the Township of Ramsay in Lanark County, (Upper Canada West) Ontario, Canada. To note, Confederation of Canada did not happen until 1867 – so it was simply known as Upper Canada and Lower Canada (Quebec).<sup>32</sup>

From the Ships List: "List of emigrant settlers from the South of Ireland embarked on board of the **STAKESBY** transport for passage to Quebec - Cove of Cork 8th July 1823.<sup>33</sup> The Stakesby arrived at Quebec September 2nd and the passengers proceeded to Montreal on the steamboat **New Swiftsure** on September 5th, with Mr. Hamilton, surgeon in charge and Peter Robinson. (transcription from microfilmed copies of two lists; may contain errors; there may be omissions; wide variation of some ages, between lists; additions at end of list)"

A genealogist's note to keep in mind for the following records in Upper Canada (Ontario):

- Confederation happened in 1867. Prior to that, records were scarce, and birth records weren't recorded.
- ♣ Lanark County and Perth County are very far from one another (close to a 6-hour drive by modern means of transportation). It would have taken the family great effort to travel that distance in the 1850s. I suspect they traveled via railroad.
- ♣ There is a town in Lanark County called Perth. A few children were baptised at the church here in Perth, at St. Johns. It is closer to Ottawa, Canada's capital city, about an hour south of it.
- Perth County is far southwest Ontario, near Middlesex and Huron Counties, and near the US border leading into Michigan.

# PETER ROBINSON'S REPORT ON 1823 EMIGRATION TO THE BATHURST DISTRICT OF UPPER CANADA<sup>34</sup>

Transcript: (no image)

(circa.March 1824)

Sir

I have the honor to report to you for the information of the Right Honorable Earl Bathurst that having received directions from His Majesty's Government to proceed to Ireland for the purpose of superintending a limited emigration to the Province of Upper Canada, I left Liverpool on the 18 and arrived at Fermoy in the County of Cork on the 20th of May 1823.

Being a stranger in Ireland I was ordered to act under the advice of Lord Ennismore and the Magistrates, and in order to receive the full benefit of their assistance, I made Fermoy my principal place of residence - I was happy to find that the very liberal conditions proposed by His Majesty's Government to such as were disposed to emigrate, met the cordial approbation of all the Gentlemen to whom they were communicated - Lords Ennismore, Kingston ODoneraile, W. Bucher M.P. W.Iephson & the Rev. Dr Woodward were most friendly to the scheme, anxious for its success, and ready to give me every assistance in their power --

On the 2d of June my final instructions arrived, and as the Gentlemen I was directed to consult were unanimously of the opinion that I should take as many persons as possible from the disturbed Baronies in the County of Cork, which were at that time in a very distracted state - I caused several hundred copies of the memorandum containing the terms of emigration to be distributed in the Towns of Fermoy, Mitchelstown, Doneraile, Charlesville, Newmarket, Kanturk, Mallow & the villages within that circle - The Noblemen and the principal Magistrates in the different Towns considered in the kindest manner to become the organs of communication with the persons wishing to emigrate, to take in their names and the number of their respective families as it was intended from these lists to make under their advice and direction a final selection - The whole business was conducted in the true spirit of conciliation for in every Town or Village from which emigrants were expected I called upon the Roman Catholic Priest as well as the more respectable inhabitants to afford them an opportunity of asking any questions they chose to put, or of giving them an account of the nature of the benefit which Government offered through me for the acceptance of the poor-

Several Priests entered into the matter with much zeal, and one of them promised to read the memorandum from the pulpit and to explain to his parishioners the great advantage to themselves and families which must accrue from emigrating in such liberal conditions-

Not satisfied with giving all the information I could to the Magistrates, and calling upon the principal inhabitants, I made myself accessible to all the people and entered patiently into their views and feelings answering their enquiries and affording them as true a description of the Country as I was capable of giving-On these occasions it was that I found the benefit of being well acquatinted with Upper Canada the place of their destination- I was able to set before them the length of the journey the obstacles in their way, and the means of removing them. I explained the manner of clearing lands and cultivating the virgin soil, I dissipated their apprehensions concerning wild beasts and the danger of being lost in the woods- Many after being satisfied in regard to the excellence of the soil and climate of Upper Canada, were anxious to know whether

in case they liked the country there would be room for their friends and whether they would likewise be granted lands and enjoy the same benefits and privileges which were now offered to them- To these enquiries I made answer that I could not give them any positive information as to the future intentions of Government, but this I knew that there was room enough in Canada for many more than would ever come from Ireland, and that if they were industrious and sober they would be able in a few years to send for their friends and relations themselves if no public assistance should at that time be given to emigrants

The care thus taken to give every information produced the happiest effects, the people received the proposals most readily and were exceedingly grateful for the kind attention with which they were treated- I had been frequently told that much opposition might be expected from the Roman Catholic Priests as the plan if successful would lessen their congregations and circumscribe their influence but so far was this from being the case that in most of the parishes which I visited I found them on the best terms with the resident Protestant Clergyman, and instead of giving unfavourable impressions of the plan, they most generally gave it their support

There was a difference of opinion among many intelligent persons whom I found it advantageous to consult, regarding the description of persons that ought to be received. It was contended that a few respectable persons should be taken by way of encouraging others, and of proving that there was no deception, but that the measure was intended chiefly for the relief and comfort of the poorer classes. On the other hand it was justly remarked, that to receive persons in tolerable circumstances was not giving the experiment a fair trial, for unless the paupers themselves could be settled comfortably at a very moderate expense, emigration as a public measure ought to be abandoned. That there was no wisdom in affording to persons having some property the means of emigrating, because they had already the power if so disposed of proceeding to Canada- That there might be reason for not wishing that even small capitalists should remove from such a Country as Ireland, and certainly strong reason for not giving them direct encouragement

After a little time the general opinion accorded with the determination of His Majesty's Government, to make such a fair experiment of an emigration confined to paupers as would not only settle its expediency on the ground of expense, but what was of still more consequence show how far it was calculated to promote the permanent comfort and happiness of the persons sent out-

Acting therefore agreeably to this determination, I confined myself strictly to the selection of persons of no capital whatever, and who might more properly be called paupers, satisfied that if such succeeded in Canada, persons disposed to emigrate having some property would be sufficiently encouraged, since they would have the fullest evidence before them that industry and prudence without their advantages would in time ensure success-

In regard to the former conduct of those who applied to emigrate, I made no particular enquiry, being convinced that a change of circumstances so great as that of becoming proprietors of land themselves and far removed from the influence of the turbulent the selfish and designing would effectively cure the discontented- Moreover it was judged expedient by the Gentlemen under whose guidance I acted, to take them out of a troubled District that some of the more fiery spirits might be disposed of and consequently those left behind would find more steady employment and be induced to live in greater tranquillity-

On the 2d of June I began to advertize for emigrants and to distribute copies of the terms on which the Government was disposed to send them to Canada, before the end of the month I had distributed 600 tickets for embarkation, a greater number than I could have taken, but I acted on the presumption that some would keep back from sickness or imaginary fears and apprehensions or the advice of friends, the event proved that I was right for on the 1t of July 460 only were embarked but I was able next day to select 108 more making in all 568 which was as many as could be accommodated- During the time that I was collecting the people, two vessels of about 500 tons each were engaged in the Thames to carry them from Cork to Quebec, these vessels

were amply supplied with provisions and every comfort in case of sickness that could be imagined. Two medical officers of experience, one for each ship were employed. The vessels and stores were strictly inspected, and they were in every respect as well found as if they had been fitted out by a company of passengers for their own convenience safety and comfort

Thus in rather less than a month from the time of issuing the proposals the emigrants were on board, and the ships ready to sail, such was the promptness of Government in making its arrangements, and the active exertions of the Nobility and Magistrates in enabling me to select the requisite number- For their kindness in thus forwarding the object of my journey to Ireland as well as their attentions to myself I feel exceedingly grateful

During the voyage nothing happened of importance, the rations were abundant and comfortable the men were allowed cocoa for breakfast and nearly half a pint of spirits which was perhaps not too much. The women and children were allowed tea and sugar- The best proof of the attention paid to them on the voyage, arises from the good health which they enjoyed as only one woman and eight children died on the passage and these from small pox, which had unfortunately got into both ships, and not from any causes that could be attributed to their change of circumstances or situation

It may be worth remarking as it is a characteristic of the fondness of the Irish people for potatoes that the men preferred them to the cocoa, which they refused for several days to take till they saw the officers of the ships repeatedly breakfasting upon it- The children during sickness called out for potatoes, refusing arrow root or any other aliments more congenial to their situation & nothing could prevail on man woman or child to eat plumb pudding, which as is usual on ship board was part of the Sundays dinner-

Few of them would eat the best English cheese and when it was served out as part of their ration it was most commonly thrown overboard-

We arrived at Quebec in the Stakesby on the 2d of September after a passage of eight weeks, the Hebe had been in port two days- I shipped the people from the transports on board the steam boats without landing them, and proceeded to Montreal on the 4th having been detained only two days- We were much facilitated in our progress by the orders which His Excellency Lord Dalhousie had given before our arrival to the Quarter Master General to find provisions and transport as far as Prescott in Upper Canada a distance of about 320 miles

We reached Montreal on the 6th and finding the means of transport ready, I forwarded the emigrants by land immediately without stopping in Montreal to La Chine distant ten miles. There we remained two days and then set out in boats to Prescott, the crews of each consisting chiefly of emigrants with two Canadians to guide & steer- Notwithstanding the rapidity of the River and unskilfulness of the men few of whom had ever been in a boat we got to Prescott on the 15th. a Commissary had preceded us with one months provisions, but finding no commissariat establishment at Prescott and being unwilling to incur what I considered an unnecessary expense I receipted the months supply and allowed the commissary to return to Montreal

Here I likewise parted with the two Surgeons Mr Hamilton & Mr Dixon whose indefatigable attention to the emigrants and kind and benevolent treatment cannot be sufficiently praised, such was their zeal and anxiety for the success of the emigration, that they volunteered their services from Quebec to Prescott a distance of more than three hundred miles, and were of great service in preserving the health of the emigrants while passing up the River in boats, which was the most difficult and tedious part of the journey-

I could not see them depart without regret, and tendering to them my grateful acknowledgements, as the good conduct of the people during the whole voyage and afterwards, may in a great measure be attributed to their steady and humane attention to their wants

On the 18th I left Prescott and proceeded across the Country in Waggons to the Mississippi River, a distance of about fifty miles and arrived on the 22d. Here I found that orders had already been given by His Excellency I.Perigrine Maitland to afford me every possible facility in placing my people on such lands as were vacant & grantable in this neighbourhood- His Excellency also had the goodness to place at my disposal many articles useful to settlers which remained in the King's Stores and took a very warm interest in the success of the undertaking-

The Township of Ramsay which the Mississippi intersects appeared to be exceedingly eligible, but I found that rather more than one half had been settled three years before by Scotchmen from the neighbourhood of Glasgow-

The adjacent Townships Huntley, Goulbourn & Pakenham were also partially settled by disbanded soldiers & others- Being anxious to settle my people as near each other as possible, I determined to examine carefully what lands remained in these Townships at the disposal of Government, & fortunately I found a sufficient number of vacant lots fit for settlement- I therefore located in the Township of Ramsay eighty two heads of families, in Pakenham twenty nine, in Bathurst one, in Lanark two, in Beckwith five, in Goulbourn twenty six, in Darling three, and in Huntley thirty four- Making in all one hundred and eighty two- As there were no barracks or Government Buildings in the neighbourhood the whole party without shelter, my first care was to provide log houses for them, and that on their respective lots- Fortunately the Autumn was unusually dry and warm and I completed this object by the first of November

To do this I was obliged to go to some additional expense, as the settlers were not sufficiently aquainted with the use of the axe to put up Log buildings themselves- However I feel well assured nothing tends so much to fix the attention of the emigrant to his newly acquired property, and to ensure his becoming a permanent settler as a little care & attention in placing him on his Land

I have much pleasure in being able to state that altho the detailed account of the expenditure cannot yet be made out, as there is a cow and some little articles still to be supplied, will fall within the estimate, so that this part of the experiment proved most satisfactory. The second part of the experiment "how far an emigration of the poorer classes to Canada is calculated to promote their paramount comfort and happiness" will be best proved by a reference to the letters of the persons sent out to me of them so late as the 20 Feby stating their good health & complete satisfaction with the country and climate, and earnestly inviting their friends to join them, and to the fact that every head of a family will have from three to four acres of land cleared and ready to plant this spring

I therefore feel warrented in stating that this emigration to the Province of Upper Canada committed to my superintendence has completely succeeded

Figure 29: Map of Ramsay Township, Lanark County, Upper Canada (Ontario), circa 1874-1881:<sup>35</sup>



The Lots are shown in Roman Numerals along the bottom and the Concessions are shown as numbers beginning at the bottom upward. (ie. Lot 9 (or IX), Con 9 is where it reads the letters 'TRAL' in CANADA CENTRAL RAILWAY, written sideways on the map. Each rectangle block represents a Lot size of 200 Acres. Within the 200 acres of Lot 9, Con 9, it contained access to the Mississippi River. While the John Mara family wasn't




Figure 31: Pre-Confederation Patent Map of Ramsay (Close-up) with John O'Mara at center, on Lot 9, Con 9:

From the Pen of Rev. Thomas Williams, a location agent in the 1830s, explains:37

"These maps... were disfigured with peculiar marks, which indicated the allotment of land in them to certain purposes and persons.

"Indeed a very large proportion of the land was shut away altogether from the use of actual settlers.

"There was first the Crown reserves – one-seventh of all the lands; these had a mark on them like a blur made with the end of a finger dipped in pale red ink. These were sold or granted about that time to the Canada Company, and were open for settlement by purchase.

"Then there was another seventh of the land, with a dusky blur on them, made as if with a finger-tip dipped in common black ink. These were the clergy reserves, and at that time might be leased, but not bought.

"Besides the above, there were in all the townships lots with the letter D written upon them, some in single two-hundred-acre lots, and sometimes in blocks of several hundred or a thousand acres. These, we are told, belonged to certain great estates of favoured persons in different parts of the country and deeded to them; and they were always the best lands, but they were "taboo" to the settler.""

"One-seventh of the land was Clergy Reserve. When the Imperial Government, under the authority of the Constitutional Act of 1791, directed the authorities of Upper and Lower Canada to commence reserving one-seventh of the lands for support of a Protestant clergy, they gave instructions that the lands so to be reserved were to be intermixed with those to be granted to individuals, the intention being to have them chequered over every township in the proportion of one-seventh of the whole. It, however, was found difficult to comply with this requirement, as in some districts nearly all of the lots had been granted. Reserves were therefore, in many instances, made in blocks in the nearest ungranted townships. Long before any grievance was felt on religious ground, there was a general dissatisfaction among the colonists at the obstruction to settlement presented by the reservation. For a long time there was no authority to sell the clergy reserves, and the original idea seems to have been to create a tenantry in each township which was eventually to be a parish." <sup>38</sup>

In 1838, John Mara got a land patent for Lot 9, Con 9, Ramsay in lieu of Lot 11. He cleared 5 acres and built a house on it. It was recommended he get a deed 14 Jun 1838. Originally belonged to Clergy Reserves. Full 200 Acre Lot.

On 13 Dec 1849, he sold all 200 Acres for \$2400.00 to James Snedden.



The land at Lot 9, Concession 9 was originally Crown lands (the Queen owned) and used as Clergy Reserve. It was settled by John O'Mara and family. After he sold it in 1849 to James Snedden, It changed hands again in 1854 to William Snedden and wife, and then two years later in 1856 it was mortgaged to B & O Railway. Afterwards, William Snedden repurchased it, and then surnames of Cumming, Turner, and Lowry owned the land before it was given back to Crown and given to Department of Transportation and Commerce in 1971.







These photos were taken by me on a drive out in July 2022 to Ramsay, Lot 9 Con 9, presently owned by "Rosedale Farms" since 1917. The owner, Ed Lowry, passed away in 2017. There are still grown children connected to the property and they may be willing to give info about the house and land. I did not want to trespass, but took photos from the entrance of the long driveway leading to the old, gabled house. This property is nestled on County Rd 29, between two rock quarries. The hardships of clearing the land which John Mara endured is still evident in that the only thing to farm around here must be rocks. A video of the area is included in the images I am sending to you.

A railroad track runs diagonally through the Lot, paralleling the Mississippi River on the far right, and Lot 9 carries through to the other side of the river.

The Latitude and Longitude Coordinates for this Lot are: 45.198° N 76.164° W. You can enter those coordinates in "Google Maps" to create directions from other places the O'Mara family lived, to see routes they took to head into southern Ontario. It passes right through London, Middlesex as you head into the United States.

On the same map application, by zooming into the Lot on display, I was able to bring this modern satellite image of Lot 9 Con 9 into view. Lot 10, just north of it is a quarry and excavation site (not shown here) — ironic since one of the complaints by John Mara was the amount of rocks he had to dig through to settle and clear the land. On the far left of the above image, you see three driveways and houses and farms, sitting accessible off the Country Rd 29. These three farms are now all on Lot 9, as it has been divided. I'm unsure of the dates of those houses and/or if they belonged to John Mara. The one in the center is the oldest, and has green gables on its roof, which would have been an earlier style from the 1800-1900s. It may be the original house, making it nearly 200 years old. The other two are likely added after 1940 and are modern.
